Pool registration and pass distribution will be held on the following dates and times: Wednesday, May 22<sup>nd</sup>, 29<sup>th</sup>, & June 5<sup>th</sup>: 12PM-2:30PM
Thursday, May 23<sup>rd</sup>, May 30<sup>th</sup>, & June 6<sup>th</sup>: 12PM-2:30PM

Pool passes are required for entry. **YOUR ACCOUNT MUST BE PAID IN FULL.** Passes will be distributed to **ADULTS 18+YEARS OF AGE. This completed form and a valid ID** must be presented to pick up passes. Each property will receive 2 passes; 4 people per pass. Children under 2 will not count on a pool pass. Guests must be accompanied by a resident at all times.

Lifeguards will temporarily keep passes during every pool visit; passes will be returned upon exiting the pool.

\*\*Scheduled inspection on these dates only maybe tentative.

\*Pool rules are posted and it is the responsibility of each individual to pay attention and follow the rules. Pool hours, days, and rules are subject to change without notice. Pool may be closed for weather (rain, thunder, lightning, heat index, etc.) or maintenance without notice. Lifeguards have full authority on all matters concerning the pool. Failure to comply may result in removal from the property and pool privileges suspended. Lifeguards are not there to defend the rules; but to keep everyone safe.

## LATE POOL REGISTRATION/REPLACEMENT BY MAIL ONLY

If you are unable to attend one of the in-person registrations, passes will be distributed **by mail only** at a cost of \$1.00 per pass. Cost for replacement passes is \$1.00 each.

- (3) If there is a balance on your account, write a separate check payable to Sterling Green South CIA for the balance.
